PROPERTY DESCRIPTION

Located in the heart of Sarasota, this 4,000 sq. ft. retail building has been a pharmacy for many years, but could easily be converted to office or a retail showroom. Property is now vacant, and seller is going through A/C systems to make sure everything is in proper order for the next owner. This is a rare opportunity to own in the same complex as The Parrot Bar & Grill, Forest Lake Animal Clinic, The Medical Department Store and more.

Currently the space is set up as a main sales/display area, along with a several private offices, small server room, and 2 restrooms. Main pharmacy production occurs in two large glass walled work areas, and a huge 10'x40' compounding room. Towards the rear of the space there is a break area and storage space for inventory or files, along with a 3-room area in rear of unit that was designed and previously used as a sterile work area.

Building is a free standing but shares some maintenance expenses for common parking with neighboring properties. Owner's expenses are divided based on frontage, at a rate of 3% per 20' of building frontage, meaning 3644 is responsible for 6% of any maintenance expense for the common elements.


LOCATION OVERVIEW






